It is usually argued that widowhood is strongly associated with a wide range of deprivations across developing and less-developing countries. A woman often loses her status, living or property rights when her husband passes away. Widowed women encounter persistent abuse, discrimination, disinheritance and destitution in our society. In their article on "Sighs behind the Veils," Professor Md Mizanur Rahman et al.have explored the problems encountered by the widowed women in rural Bangladesh. It is revealed that the majority of rural elderly widowed women are deprived of the necessities of survival. This study finds that the majority of the studied elderly widowed women could not involve in decision-making process in their everyday lives.

Md. Fakhrul Alam's work on "Living with Risks of Abuse, Harassment, and Vulnerabilities" presents an ethnography of female sex workers in Sylhet, Bangladesh. The author has found some interesting information about a handful of female sex workers of Bangladesh. The writer argues that female sex workers are subjected to different forms of abuse and exploitation in the sex trade, and their human rights are also violated in this profession. It would be really interesting to see how the author explains with sufficient information how female sex workers resist, manage, and accommodate themselves in different situations.

Corruption has been recognized as a global phenomenon since the mid-1990s, yet the obstreperous effect of corruption on economic growth and development is not straightforward. Mr. Gias Uddin Khan in his paper titled "Corruption and Economic Growth: A Random Effect Approach" focuses on the relationship between corruption and economic growth worldwide using the panel data for 147 countries for the period of 2002 to 2017. The author argues that corruption has significant negative impact on the economic growth of a country.
